REITERATION ON THE IMPLEMENTATION OF DEPED ORDER 32, S. 2019, DEPED ORDER 109, S. 2017 AND DEPED ORDER NO. 44, S. 2005

To: Assistant Schools Division Superintendent Chief Education Supervisors (CID & SGOD) Education Program Supervisors Public Schools District In-Charge All Others Concerned This Division

- 1. The Department of Education issues **DepEd Order No. 109, s. 2017**, entitled "Public Manifestation of DepEd's Declaration of Schools as Zones of Peace, and as a Reiteration of DepEd Order No. 44, s. 2005" and **DepEd Order No. 32, s. 2019**, entitled "National Policy Framework on Learners and Schools as Zones of Peace" to guide the education sector in the creation of safe, inclusive, and conflict-sensitive learning environments.
- In light with this, the following shall be considered:
 - a. All schools are instructed to post the official tarpaulin designs size three by eight feet (copy enclosed) declaring schools as Zones of Peace, at least two on both sides of the school front gate, and on all other sides of or around the school to make the message prominent and noticeable;
 - b. The Department enjoins all personnel, stakeholders and the community as a whole to actively participate in and/or establish peace building initiatives to ensure the safety of the learners, personnel, and schools; and
 - c. Encourage partnership and parallel efforts with stakeholders to take part in the campaign.
