# CONDUCT OF THE 2019 DIVISION SCHOOLS PRESS CONFERENCE (DSPC) SCHOOL PAPER AND GROUP CONTESTS

This Division

- 1. The Division of Tangub City, through the Curriculum Implementation Division (CID) announces the conduct of the 2<sup>nd</sup> tranche of the 2019 Division Schools Press Conference (DSPC) with the theme "Fostering 21<sup>st</sup> Century Skills and Character-based Education" on August 30, 2019 at Function Hall I and Division Conference Hall, Tangub City.
- 2. This conference/activity aims to achieve the following objectives:
  - a. demonstrate understanding on the importance of journalism by expressing it through different journalistic endeavors and approaches;
  - b. provide a venue for an enriching learning experience for learners' interest in pursuing journalism as a career;
  - c. promote responsible journalism and fair ethical use of social media; and
  - d. enhance journalistic competence through healthy and friendly competition and training.
- 3. The one-day 2<sup>nd</sup> tranche DSPC shall include school paper and group contests in Collaborative Desktop Publishing, Radio Broadcasting both elementary and secondary English and Filipino and TV broadcasting and Online Publishing English and Filipino secondary only.
- 4. Participants of this conference/activity are the first place winners in the school level group contest and the school paper advisers/coaches in both elementary and secondary schools for the school paper contest.

- 5. Senior High School students can join in the contest with the Junior High School students-participants under secondary level category.
- 7. Advisers and coaches are responsible for the contestants' safety and security all throughout the one-day DSPC. Thus, parents' consent, medical certificate and Registration Form/Participant's Profile must be prepared, filled out and submitted in bunch before the day of the conduct of the DSPC to the Registration/Attendance Committee (Attention: EPS Gina L. Mandawe, Committee Chairman) or upon arrival on Day 1 at the contest venue.
- 8. It is expected that schools who participated in the first tranche of the conduct of the 2019 DSPC and those who will participate in this 2<sup>nd</sup> tranche of DSPC shall bring two hard copies of the school publication/school paper with 12 to 16 pages in A4 size separating English from Filipino for the Group Contest and mandatory requirement in joining the contests.
- 9. School paper advisers/coaches are encouraged to give input to their contestants on the new trends/updates on the various contest events prior to the participation of the activity.
- 10. Top three winners in every group event shall be proclaimed but only the first place winners shall qualify to the Regional Schools Press Conference (RSPC).
- 12. Included in this Memorandum are the following: 1) Matrix of Activities,
- 2) Working Committees and 3) Registration Form/Participant's Profile.
- 13. Transportation and other incidental expenses of the participants and the Technical Working Group (TWG) to this activity shall be charged against school MOOE/school publication/local funds subject for usual accounting and auditing policies, rules and regulations.
