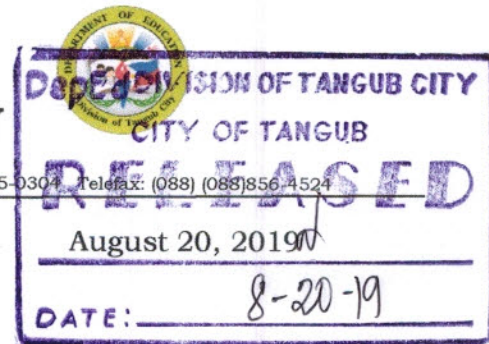

1. Relative to Division Memorandum No. 181, s. 2019 entitled Conduct of the 2<sup>nd</sup> Tranche of the 2019 Division Schools Press Conference (DSPC) for School Paper and Group Contests dated August 30, 2019, the following changes have been made:
  - a. Due to conflicting activities, the schedule of the 2<sup>nd</sup> Tranche of the 2019 DSPC for the school paper and group event contests is moved from August 30 to September 2-3, 2019 at Function Hall 1;
  - b. Submission and judging of school publications for the School Paper Contest shall be done in the morning of Day1 (September 2). Two copies shall be brought by the school paper adviser on the day of the contest;
  - c. Online publishing and collaborative desktop publishing shall be contested also on Day I (September1) at 1:00-5:00 in the afternoon.
  - d. Radio and TV Broadcasting/Scriptwriting contests shall take place on Day 2 (September 3) from 8:00 in the morning to 3:00 in the afternoon;
  - e. Awarding ceremonies shall start at 3:00 in the afternoon; and
  - f. Online publishing contestants shall provide their own wifi.

3. All other provisions of the aforementioned Memorandum still remain in effect.
4. Immediate dissemination of and compliance with this Memorandum is hereby enjoined.
