2019 BEGINNING OF THE SCHOOL YEAR (BOSY) DATA/INFORMATION COLLECTION AND VALIDATION PROCESS FOR LEARNER INFORMATION SYSTEM (LIS) AND BASIC EDUCATION INFORMATION SYSTEM (BEIS)


To: Chief Education Supervisor, SGOD and CID Program Holders of National Programs and Projects District-In-Charge (DIC) School Heads of Public Elementary, Junior and Senior High School Administrator of Non-DepEd Schools Offering K to 12 Basic Education This Division

- The 2019 Beginning of the School Year (BOSY) data collection and validation for Enhanced Basic Education System has now commenced with the issuance of the official Government Elementary School Profiles, Government Junior High School Profiles, Government Senior High School Profiles, Private School Profiles and SUCs/LUCs School Profiles.
- All public and private elementary, junior and senior high school, state 2. universities and colleges (SUCs), local universities and colleges (LUCs) and higher education institutions (HEIs) offering Kindergarten to Grade 12 are directed to register and update their learners' profile and quick count enrolment in the Learner Information System (LIS) and update the school's profile and other data elements in the Basic Education Information System (BEIS) through the accomplished data gathering forms.
- For public integrated schools, they shall accomplish only the data elements in the GESP, GJHSP and GSHSP Forms that are applicable and relevant to the schools.
- Likewise, for SUCs/LUCs and Private Schools, they shall only provide data 4 that are relevant to or applicable to their Curricular Offering Classification.
- School heads, with the assistance of the members of the School Validating Team (SVT), are hereby directed to supply, as well as conduct validation of, the data in the school profiles the soonest possible time. The official templates can be downloaded from the "downloadable forms" link under the "resources" tab in www.depedtangub.net.
- 6. Data Validation To ensure the accuracy and quality of data reported by schools in the LIS and BEIS, from school level to regional level, a Validating Team will be organized with the corresponding composition and responsibilities.




