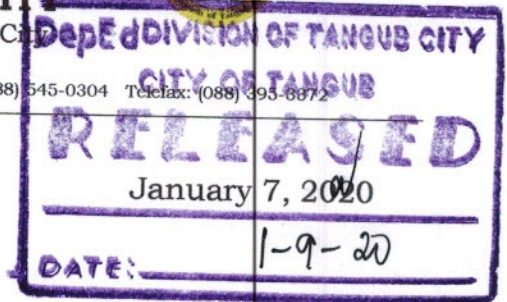

First Aid and Basic Life Support Training of Division Personnel

1. Pursuant to Republic Act (RA) No. 10121 entitled *The Philippine Disaster Risk Reduction and Management Act of 2010*, this Office is conducting First Aid and Basic Life Support Training of Division Personnel to adopt a disaster risk reduction and management approach that is holistic, comprehensive, integrated and proactive in lessening the socioeconomic and environmental impacts of disasters including climate change, and promote the involvement and participation of all sectors and all stakeholders concerned, at all levels, especially the local community; recognize and strengthen the capacities of LGUs and communities in mitigating and preparing for, responding to, and recovering from the impact of disasters on January 21 – 22, 2020 for batch 1 and January 23 – 24, 2020 for batch 2 at the Division Conference Hall, Mantic, Tangub City.
2. This First Aid and Basic Life Support Training shall promote involvement and participation of Division Personnel in mitigating and preparing for, responding to, and recovering from the impact of disasters and emergencies; recognize and strengthen the capacities of Division Personnel on First Aid and Basic Life Support in response to disasters and emergencies.
3. Attached herewith is the list of participants for batch 1 and batch 2.
4. The first aid and basic life support training is free but the Philippine Red Cross (PRC) - Tangub City Chapter *requires the participants to register for premier bronze membership (ages 5 – 65 years old) valid for 1 year in the amount of One Hundred Fifty Pesos (Php 150.00) charged to personal funds which covers daily hospital allowance (max 60 days) One Hundred Fifty Pesos (Php 150.00) per day, accidental burial assistance of Five Thousand Pesos (Php 5,000.00), accidental medical reimbursement of Five Thousand Pesos (Php 5,000.00), unprovoked murder and assault of (Php 35,000.00) and*

accidental death, disablement and dismemberment of Thirty Five Thousand Pesos (Php 35,000.00).
