

## REGISTRATION OF 2020 COMPUTER-BASED ACCREDITATION AND EQUIVALENCY (CB-A&E) TEST TAKERS

- 1. The Department of Education(DepEd), through the Bureau of Education Assessment(BEA) announces the registration period for 2020 Computer-Based Accreditation and Equivalency (CB-A & E) Test.
- 2. Applicants who opt to take the CB-A&E Test may register from **October 30- November 6, 2020.** Only ALS completers who are 15-65 years old are allowed to take CB-A&E Test, except for persons with immunodeficiency, comorbidity or other related health risks and pregnant women pursuant to DepEd Order 55, s. 2016 titled Policy Guidelines on the National Assessment of Student Learning for K to 12 Basic Education Program, and in compliance with Executive Order 112, s. 2020 and IATF Resolution No. 79.
- 3. Applicants must have a Learner Reference Number (LRN) and at least <u>28</u> points in their presentation portfolio.
- 4. Registration requirements are as follows:
  - a) original photocopy of Certification of ALS Program Completion issued by the Learning Facilitator (for ALS Learners only)
  - b) original photocopy of Birth Certificate issued by the Philippine Statistics Authority (PSA) formerly National Statistics Office (NSO). If Birth Certificate from PSA/NSO is not available, any of the following documents can be presented
    - b.1. baptismal certificate
    - b.2. voter's ID(with picture, signature, and date of birth)
    - b.3. valid passport
    - b.4. valid driver's license

- b.5. any legal document bearing the applicant's picture, name, signature, and date of birth (e.g. NBI Clearance, Police Clearance)
- c) two(2) 1x1 or 2x2 identical ID photo (white background with name tag
- d) Presentation Portfolio Assessment
- e) Medical Declaration Form
- 5. ALS Mobile Teachers and DALCIs shall provide assistance in the dissemination of information, distribution of registration and medical declaration forms, and initial evaluation and verification of applicants' required documents.
- 6. Only the registered applicants with complete requirements shall be allowed to take the test at the testing centers approved by BEA.
- 7. No payment shall be Collected by anyone involved in the CB-A&E Test Registration, Administration and issuance of Certificate of Rating.
