

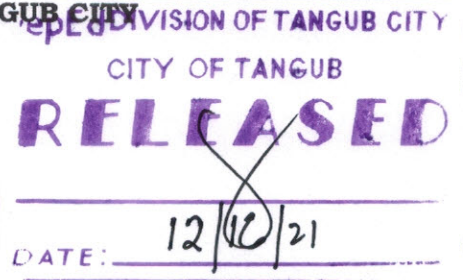



1. The Office of the Provincial Governor, through Executive Order No. 191, s. 2021 dated December 16, 2021 (copy enclosed) issued by the Provincial Governor Philip T. Tan, suspended work in all government offices under the Provincial Government of Misamis Occidental effective December 16, 2021 at 1 o'clock in the afternoon until December 17, 2021. As such, work in all offices and schools in the Division of Tangub City is suspended on the said dates.
2. All school heads shall undertake necessary measures to safeguard the facilities, equipment, and materials in school.

EXECUTIVE ORDER NO. 191
Series of 2021

**AN ORDER SUSPENDING WORK IN ALL OFFICES UNDER THE
PROVINCIAL GOVERNMENT OF MISAMIS OCCIDENTAL ON THE
AFTERNOON OF DECEMBER 16 UNTIL DECEMBER 17, 2021 DUE TO
TYPHOON ODETTE.**

WHEREAS, Section 16 of the Local Government Code of the Philippines mandates local government units to exercise powers necessary, appropriate or incidental for the promotion of general welfare, health and safety of their inhabitants;

WHEREAS, it is the mandate of the Local Government Unit to promote welfare of its constituents at all times especially during disaster and calamities;

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) is the agency of the government mandated to observe and report the weather of the Philippines and specified adjacent areas, and to issue forecasts and warnings of weather and flood condition affecting national safety, welfare and economy;

WHEREAS, on December 16, 2021, signal No. 2 has been raised in the province of Misamis Occidental by the PAG-ASA;

NOW, THEREFORE, for and in consideration of the foregoing, I, **PHILIP T. TAN**, the Governor of the Province of Misamis Occidental, by virtue of the powers vested in me by law, do hereby **ORDER**:

Section 1. SUSPENSION OF WORK IN ALL OFFICES UNDER PGMO.
Suspension of work in all PGMO offices in order to make adequate preparation and take shelter from Typhoon Odette.

Section 2. SUSPENSION OF WORK IN OFFICES UNDER THE MUNICIPALITIES AND CITIES OF MISAMIS OCCIDENTAL. All city and municipal mayors are encouraged to suspend works also.



Section 3. SUSPENSION OF WORK IN PRIVATE COMPANIES. The suspension of work for private companies shall be left to the discretion of their management. However, the prioritization of employee and safety is highly encouraged.

Section 4. EFFECTIVITY. This order shall take effect on December 16, 2021 at 1 o'clock in the afternoon until December 17, 2021.

Let copies of this Executive Order be furnished to all concerned for information and guidance.
