EXECUTIVE ORDER NO. 328 SERIES OF 2022

AN EXECUTIVE ORDER LIMITING THE MOVEMENT OF ALL PERSONS ON SATURDAYS AND IMPOSING OTHER EMERGENCY MEASURES TO STEM THE RAPID RISE OF COVID-19 CASES IN THE CITY

WHEREAS, with the sudden upsurge of the number of COVID-19 cases in Misamis Occidental, the National IATF, on January 13, 2022, placed Misamis Occidental under Alert Level 3 under the Alert Level System;

WHEREAS, the frequent movement and the resulting co-mingling and gathering of persons is the primary cause of transmission of COVID-19, especially with the hyper transmissibility of the Delta and Omicron variants of the virus;

WHEREAS, the Region 10 Inter-Agency Task Force for the Management of Emerging Infectious Diseases (R10 IATF-MEID) issued Resolution No. 1487 (S. 2021) titled "ENJOINING THE LOCAL GOVENRMENT UNITS IN REGION 10 TO DECLARE SIMULTANEOUS "NO MOVEMENT DAY/S POLICY" IN A WEEK AS A PREVENTIVE MEASURE AND TO CONTAIN AND MITIGATE THE IMPACT OF COVID-19 CONTAGION IN THE REGION";

WHEREAS, the imposition of "No Movement Saturday" during the previous outbreak was proven to be effective in reducing the increase of cases in the city, along with the bolstering of vaccination efforts;

WHEREAS, the City Courtyard is the venue of a weekly *tabo/bagsakan* where vendors of fish, livestock, vegetables, and other products convene to sell their goods every Saturday and Sunday of the week;

WHEREAS, it has been observed by elements of the City Government of Tangub that there are multiple traffic issues along Osmeña St., and overcrowding in the City Courtyard during the *tabo/bagsakan*, which inevitably results to violations of minimum public health standards, particularly social distancing, committed by vendors and customers alike, thus increasing the risk of COVID-19 transmission;

WHEREAS, Section 21(c) of the Local Government Code of 1991 allows closure of roads by the Local Chief Executives for emergency purposes, among others, the duration of such closure being specified in a written order;

WHEREAS, the sudden upsurge of COVID-19 cases in Misamis Occidental and Tangub City is an emergency that needs immediate action for the welfare and safety of Tangubanons and to prevent loss of life;

NOW, THEREFORE, for and in consideration of the foregoing, I, **JENNIFER WEE-TAN**, the Mayor of the City of Tangub, by virtue of the powers vested in my by law, do hereby **ORDER:**

SECTION 1. NO MOVEMENT SATURDAY. Two (2) Saturdays, January 29, 2022 and February 5, 2022, are hereby declared as "No Movement Saturdays" during which the movement of all persons, regardless of age, within the territorial jurisdiction of Tangub City shall be restricted, and no person shall be allowed to venture outside of their respective homes except for reasons hereinafter stated.

SECTION 2. EXEMPTIONS. The following persons shall be exempted from No Movement Saturday:

 Persons on essential and necessary errands such as purchasing of food, medicine and other basic necessities;

b. Public and private healthcare and frontline workers on official duty;

 Workers whose regular work falls on Saturdays and/or whose nature of work necessitates working on Saturdays;

d. Persons in emergency situations such as accidents, health emergencies and the

like; and

e. Persons attending religious activities such as masses, necrological services, last prayers for the dead, funerals, inurnments, weddings, baptisms, provided, that only immediate family members are allowed to attend necrological services, last prayers for the dead, funerals, inurnments, weddings and baptisms, provided further, that there shall be strict compliance with the minimum public health standards, especially wearing of facemasks and social distancing during these activities, provided furthermore, that in no case shall there be any kind of gatherings, meals, fellowships, church fiestas, and patronal fiestas, and the attendees shall immediately disperse from the venue at the end of the aforementioned religious activities.

Any person found outside of their residences during No Movement Saturdays are obligated to immediately show proof of their exemption upon inspection by the Philippine National Police, Keepers for Peace and Rescue Team (KPART) and/or representatives of the Tangub City COVID-19 Task Force, otherwise, they shall be presumed to have violated the policy on No Movement Saturday.

SECTION 3. SAFETY MEASURES ON THE CONDUCT OF TABO/BAGSAKAN.

- A. PLACEMENT OF VENDORS. Vendors participating in the tabo/bagsakan shall occupy the designated areas within the Courtyard premises and along the circumferential/access roads therein, as directed by the City Market Supervisor who shall ensure that the spacing of the vendors shall accommodate the strict enforcement of the two (2) meter social distancing of both vendors and customers alike.
- B. NO ENTRY OF VEHICLES. No vehicles, motorcabs, pedicabs and motorcycles shall be allowed entry into the City Courtyard premises, with exception of Public Utility Vehicles, such buses and vans, the movement of which shall be limited to their respective designated parking/loading areas.

Delivery vans and/or trucks may enter the City Courtyard according to their set schedules and/or as directed by the City Market Supervisor.

- C. ALTERNATE PARKING AREAS. The road shoulders of the Manga-Maloro road, as well as the Courtyard-side road shoulder of the Osmena St, shall be utilized as temporary parking areas for four-wheeled vehicles, motor-cabs and motorcycles, as designated under the Sketch Map attached herewith as Annex "A", to be enforced by the Keepers for Peace and Action Rescue Team (KPART) who shall ensure proper spacing and orderly arrangement of vehicles.
- D. EFFECTIVITY. The provisions on the safety measures on tabo/bagsakan under this Section shall be implemented exclusively every Saturday and Sunday of the week, from 3:00 o'clock AM to 12 o'clock midnight, only on January 29 and 30, 2022, and February 5 and 6, 2022.

SECTION 4. PENAL CLAUSE. Violations of this Executive Order shall be penalized under the applicable provision(s) of City Ordinance No. 2020-04-014, as amended, otherwise known as the Emergency COVID-19 Ordinance, with the following penalties:

FIRST OFFENSE: a fine of PhP1000.00 and/or imprisonment for one (1) day

SECOND OFFENSE: a fine of PhP2000.00 and/or imprisonment for three (3) days

THIRD OFFENSE: a fine of PhP5000.00 and/or imprisonment for ten (10) days.

SECTION 5. SEPARABILITY CLAUSE. If any part or provision of this Order is held invalid or unconstitutional by a competent court, the other parts or provisions not affected shall remain valid and effective.

SECTION 6. REPEALING CLAUSE. All orders, issuances or parts thereof which are inconsistent with this Executive Order are hereby deemed repealed or modified accordingly.

SECTION 7. **EFFECTIVITY.** This Executive Order shall take effect immediately upon approval and shall remain in effect until revoked.
