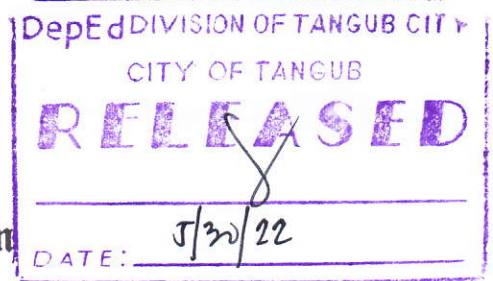

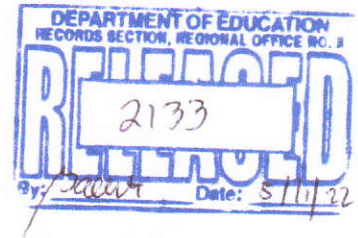

- c. identify lessons learned and areas for further development.


