COMPOSITION OF THE HUMAN RESOURCE MERIT PROMOTION AND SELECTION BOARD (HRMPSB) FOR THE SELECTION OF CHIEF EDUCATION PROGRAM SUPERVISOR (SGOD & CID) POSITIONS

1. Pursuant to DepEd Order No. 66, s. 2007, entitled "Revised Guidelines on the Appointment and Promotion of other Teaching Related Teaching and Non- teaching Positions, this Division issues the updated composition of Human Resource Merit Promotion and Selection Board (HRMPSB).

2. To further achieve the principles of merit and fitness; objectivity and uniformity in evaluation; and strengthening of the selection process in the Department, this new composition shall apply to the appointment and promotion of Teaching and Related Teaching Group such as; Teacher II and Teacher III; Education Supervisor I, II and III; Chief Education Supervisor, Education Program Specialist I and II, Senior Education Program Specialist, Chiefs Education Program Specialist, Guidance Counselors, Guidance Coordinators and other teaching and related teaching positions indicated in the Magna Carta for Public Schools Teachers, except School Heads- Principals and Head Teachers; and all Non- Teaching positions.

3. However, due to the vacancy of Chief Education Program Supervisors and a member of the previous HRMPSB is an applicant of the said positions, this Office designates an alternate member.
