#### CORRIGENDUM AND ADDENDUM TO DIVISION MEMORANDUM NO. 230, S. 2022

1. Relative to Division Memorandum No. 230, s. 2022 titled "Dissemination of Unnumbered Memorandum from the Office of the Assistant Secretary for Youth Affairs and Special Concerns on the Interim Guidelines of the Youth Commission on Elections and Appointments (Youth COMEA) for School Year 2022-2023", the following changes and additional information has been made:

a) Conduct of Division Federated Supreme Pupil Government (DFSPG) Election and Division Federated Supreme Student Government (DFSSG) Election will be moved from September 22, 2022, to September 27, 2022.

b) The venue for the Division Federation Election will be held at the Computer Laboratory of Mrs. Floresil C. Enayo at Tangub City National High School.

c) Scheduled conduct of Elections are the following:

Student Government	Date	Time
DFSPG	September 27, 2022	8:30 a.m 12:00 p.m.
DFSSG	September 27, 2022	1:30 p.m 5:00 p.m.

- d) Participants to this Division Federated Elections are the elected School-Based SPG/SSG Presidents with one (1) voting power each. In case where the elected President is not able to represent his or her respective school in the Division Federation Election, he or she shall not be elected in any position and is not eligible to any voting power. He or she cannot be represented by any officer next in his or her line. The rest of the body that will not be elected in any position will be designated as Board Member.
- e) To eliminate disruption of classes, elected SPG/SSG President shall be accompanied by their school head.
- f) Strict adherence to public health and safety protocols is hereby encouraged.
- g) Travelling and other incidental expenses of participants are chargeable to local funds subject to the usual accounting and auditing rules and regulations.
