- 1. Pursuant to DepEd Order No 031 S. 2018 re Policy Guidelines in the Implementation of Comprehensive Sexuality Education, and Division Memorandum No. 331 S. 2021 re the Online Training and Capability Building on Integrating Comprehensive Sexuality Education, this Division enjoins all schools to implement CSE Programs and Projects through curriculum integration across learning areas, information dissemination, and advocacy campaigns networking and partnerships.
- 2. The schools are expected to conduct activities not limited to the following:
 - a. Develop a School Action Plan for CSE Integration in the Curriculum;
 - Cascade CSE at the school level through School Learning Action Cell (LAC) or CSE topics part of the school Gender and Development (GAD) activities;
 - c. Include CSE implementation in the agenda during SGC/PTA meetings and other school assemblies to orient the school stakeholders and to gain support for the implementation;
 - d. Ensure inclusion of CSE programs and projects in the development of the School Improvement Plan (SIP), Annual Implementation Plan (AIP), and Work Financial Program (WFP). CSE Activities can be sourced from Gender and Development (GAD Fund), Maintenance and Other Operating Expenses (MOOE), and other sources:
 - Encourage teachers to include in their action researches the CSErelated topics; and
 - f. Submit via email at jolito.vince@deped.gov.ph the school CSE Action Plan, MOVs of information dissemination on CSE activities, and photo collage that CSE is integrated into the lesson (at least 1 integration per teacher in the identified learning area during the third or the fourth quarter of this school year). The lesson taught is observed by the superior either the school head or master teacher.
