SUBMISSION OF UPDATED/UNEXPIRED PROFESSIONAL LICENSE OF TEACHERS

- 1. Relative to the 2017 Omnibus Rules on Appointment and Other Human Resource Actions (ORA OHRA) issued by the Civil Service Commission (CSC), and as per Rule II-Sec.4, (Requirements for Regular Appointment), which states that one of the requirements for original appointment, promotion, transfer, reappointment and reemployment in the government service, including that of the Department of Education (DepEd), is a valid professional license issued by the Professional Regulation Commission (PRC) for positions involving practice of profession if he/she does not possess a valid professional license as required by the PRC.
- 2. In view hereof, all personnel are hereby reminded of the provision of the 2017 Omnibus Rules on Appointment and Other Human Resource Action in relation to Republic Act No. 1080 (An Act of Declaring the Bar and Board Examinations as Civil Service Examination) and required to update and renew their professional license with PRC.
- As such, all personnel including teaching and non-teaching holding professional license with PRC are required to submit a photocopy of their updated/unexpired PRC license at Human Resource Office on or before April 7, 2023.
- 4. Submission of documents will be per school and shall be fastened in a folder which will include the list of teachers following the attached template.

5. Immediate dissemination and strict compliance to this Memorandum is enjoined.
