ORIENTATION-WORKSHOP ON ADOLESCENT REPRODUCTIVE HEALTH PROGRAM - ARH (OK sa DepED PROGRAM)

- 1. One of its flagship programs of Oplan Kalusugan sa Department of Education (OK sa DepED) is the Adolescent Reproductive Health (ARH) program which aims to support DepEd's delivery of its mandates under the Republic Act (RA) No. 10354 titled Responsible Parenthood and Reproductive Health (RPRH) Act of 2012 calling for age and development-appropriate reproductive health education having a supportive school environment. Republic Act No.11166 titled The Philippine HIV and AIDS Policy Act also mandates that the Department ensures the development and provision of psychosocial support and counseling in learning institutions for the development of positive health, and the promotion of values and behavior pertaining to reproductive health.
- 2. In view of the existing policies and to further strengthen the Adolescent Reproductive Program, this Department through the Schools Division of Office (SDO) of Tangub City particularly the Schools Governance and Operation Division School Health Section shall conduct an **Orientation-Workshop on Adolescent Reproductive Health Program (OK sa DepED PROGRAM)** to be held on July 28,2023 at Division Conference Hall, DepEd Division Office, Barangay Mantic, Tangub City, 8:00 AM to 5:00 in the afternoon.
