1. Relative to Division Memorandum No. 158, s. 2023 titled Interim Guidelines of the Learner Government Program (LGP) for School Year 2023-2024, this Office through the School Governance and Operations Division – Youth Formation Section (SGOD-YFS) announces the changes and additional information as follows:

- a. Conduct of Division Federation of Supreme Elementary Learner Government (DFSELG) Election and Division Federation of Supreme Secondary Learner Government (DFSSLG) Election will be moved to July 6, 2023, for a similarly important activity.
- b. The venue for the Division Federation Elections will be held at the Computer Laboratory of Mrs. Floresil C. Enayo and Mr. Jelly James Cortes at Tangub City National High School.
- c. Scheduled conduct of Elections are the following:

DFSSLG	July 6, 2023	1:30 pm – 5:00 pm

- d. Participants to this Division Federation Elections are the newly elected school-based Supreme Elementary/Secondary Learner Government (SELG/SSLG) for School Year 2023-2024 with one (1) voting power each. In case where the elected President is not able to represent his or her respective school in the Division Federation Election, he or she shall not be elected in any position and is not eligible to any voting power. He or she cannot be represented by any officer next to his or her line. The rest of the body that will not be elected in any position will be designated as Board Member.



**INTERIM GUIDELINES OF THE LEARNER GOVERNMENT PROGRAM (LGP)  
 FOR SCHOOL YEAR 2023-2024**

To: Assistant Schools Division Superintendent

1. Pursuant to OUOPS No. 2023-03, this Office announces the implementation of the Interim Guidelines of the Learner Government Program (LGP) for School Year 2023-2024 by all public elementary and secondary schools.
2. To ensure consistency pursuant to DepEd Order No. 21, s. 2019, the Student Government Program shall be known as Learner Government Program (LGP), while SPG and SSG will be known as Supreme Elementary Learner Government (SELG) and Supreme Secondary Learner Government (SSLG), respectively.
3. For the last three (3) school years, the said elections were conducted during the first quarter of the school year. However, with the goal to transition smoothly and prepare accordingly for the succeeding school years, the conduct of the said elections shall be moved back to the last quarter of its preceding school year.
4. In line with the preparations for School Year (SY) 2023-2024, the SELG and SSLG elections shall be conducted on the last quarter of SY 2022-2023 following the schedule(s) below:

Date(s)	Activity
June 5-23, 2023	School-Based Elections
June 23, 2023	Submission of Enclosure 13: Registry of Elected Officers
June 26-30, 2023	District/Division Elections

5. 6. Further, all public elementary and secondary schools nationwide are mandated to facilitate learner-led clubs and organizations' elections and other relevant practices that will meaningfully support learners' initiatives and respond to varied contexts.

7. Private schools, technical and vocational institutions, and higher education institutions, including state and local universities and colleges offering K-12 Basic Education Program are encouraged to implement these guidelines according to their philosophy, vision, and mission, with the approval of their respective DepEd Regional Offices. Educational schools and institutions are allowed to contextualize the guidelines according to their mandates and own structure.
8. School heads are enjoined to support and monitor the implementation of the SELG and SSLG elections for SY 2023-2024.
9. All expenses incurred relative to the conduct of all activities related to SELG and SSLG elections for SY 2023-2024 shall be charged to School Maintenance and Other Operating Expenses (MOOE), local funds or other available funds subject to the usual accounting and auditing rules and regulations.
10. Immediate and wide dissemination of this Memorandum to all concerned is enjoined.
