CONDUCT OF NATIONAL LEARNING CAMP (NLC) 2023

1. The National Learning Camp (NLC) is one of the learning recovery strategies aligned with the MATATAG Agenda to provide transformative, concrete, and targeted reforms to further improve the country's education system.
2. Anchored on MEMORANDUM DM-CT-2023-164 on the implementation of the NLC, in line with this, the Division of Tangub City will conduct the activity in all schools from July 24 to August 25.
3. Having the nature of a camp, teachers shall ensure that the teaching-learning process inside the classroom integrates fun and a sense of fulfillment whenever learners experience success in learning. They are highly encouraged to harness learners' creativity and resourcefulness to make learning compelling and engaging while working towards the attainment of learning competencies and standards.
4. To enhance the overall learner experience in the NLC, schools may collaborate with relevant external stakeholders to conduct fun-filled educational activities that stimulate learner interest. Thus, schools shall designate spaces within the school grounds conducive to the conduct of these activities and devise creative ways where learners can feel free to participate and build their interests in meaningful ways.
5. Since the NLC entails the services of teachers beyond the regular school days, teachers together with those involved in the conduct of remediation classes as well as enhancement and intervention activities, shall be provided with the following incentives, subject to government rules and regulations:
 - a. Vacation Service credits
 - b. Certificate of Recognition for Teachers; and
 - c. Other incentives, subject to availability of funds and guidelines set.

6. PSDICs and school heads are directed to be guided with the timetable:
 - June 20 – July 8 - Pre-Assessment for Grade 7 & 8
 - July 4-8 - Marketing and Advocacy which include Orientation of PSDICs, School Heads, Teachers and stakeholders.
 - July 14 – Submission of Class Program and List of Learners
 - July 17 – Dry Run
 - July 24 – Opening of NLC
 - July 25 – August 24 – Implementation of the Program
 - August 25 – Submission of Narrative Report
 - August 29 – Post Conference and Evaluation
7. For documentation and reporting, all Public Schools District In-Charge (PSDICs) are required to submit five (5) best photos everyday per school in the conduct of their NLC.
8. All PSDICs and Education Program Supervisors (EPSs) are directed to monitor the activity of their respective districts.
9. There will be a School Heads'/Principals' NLC Orientation Program on Monday, July 10, 2023, 3:00 p.m. at Division Conference Room.

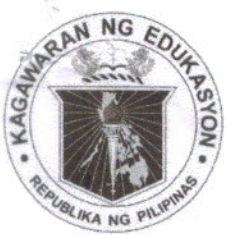
