  - d. provide close horizontal and vertical coordination and consultation among DepEd, COMELEC and partner agencies involved in the 2022 NLE;
  - e. complement the other government agencies` efforts for an honest, orderly and peaceful election; and
  - f. perform other related functions deemed necessary.
- 5. All other provisions in the previous Memorandum remain in effect.
