WHEREAS, on June 13, 2023 the procurement opportunity was published in the PhilGEPS website and the same was posted in the premises of the Division of Tangub City and its official website for at least three (3) consecutive days.

WHEREAS, after the deadline for submission of bids/quotations, there were three suppliers who responded to the procurement opportunity namely: Kusina ni Marmita Catering Services, Choylen's Grill and Brenda's Busganan.

WHEREAS, upon opening the Request for Quotation it was found out that the three prospective bidders are qualified bidders.

WHEREAS, out of the three prospective bidders, **Kusina ni Marmita Catering Services** has the Lowest Calculated Responsive Quotation and has met the specifications stated in the Request for Quotation.
