## Resolution to Recommend Approval for Adopting Alternative Method of Procurement

WHEREAS, the Division of Tangub City has a Purchase Request with PR No. 0723125 for the Procurement of Meals and Snacks for Capacity Building for G 7 & 8 English, Science, & Math Teachers on the Implementation of the National Learning Camp. with Approved Budget for the Contract (ABC) of Three Hundred Ninety-Six Thousand Pesos (Php 396,000.00).

**WHEREAS**, as a general rule, all procurement shall be done through competitive bidding except whenever justified by the conditions in order to promote economy and efficiency, may resort to any of the alternative method of procurement;


**WHEREAS**, one of the functions of the BAC is to recommend to the HOPE the mode of Procurement as indicated in the APP but cannot be pursued for the actual conditions applicability that also ensure that the most advantageous price for the government is obtained;

**WHEREAS**, BAC recommends such alternative method of procurement for the approval of the HOPE in compliance with NPM 169-2012 issued by the GPPB:

WHEREAS, the Procurement of Meals and Snacks for Capacity Building for G 7 & 8 English, Science, & Math Teachers on the Implementation of the National Learning Camp, is recommended for Negotiated Procurement under Small Value Procurement be adopted since such procurement does not exceed the threshold of Php 1,000,000.00 as prescribed in Annex H of the Revised IRR of RA 9184;

**WHEREAS**, invitations be posted thru PhilGEPS and procurement entity's website wherein price quotations must be obtained from at least three suppliers, contractors, and consultants of known qualification from the registry of suppliers of the procuring entity;

**WHEREAS,** the conduct of Negotiated Procurement under Small Value Procurement is delegated to BAC Alternative Methods of Procurement per SO # 80 s 2016 as prescribed in Letter "J" of Revised IRR of RA 9184.



NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To recommend the procurement for the Procurement of Meals and Snacks for Capacity Building for G 7 & 8 English, Science, & Math Teachers on the Implementation of the National Learning Camp with Approved Budget for the Contract of Php 396,000.00 be procured through Alternative Method of Procurement-Negotiated Procurement under Small Value Procurement.
- b) To recommend for approval of the Schools Division Superintendent of DepEd, Division of Tangub City the foregoing findings.
