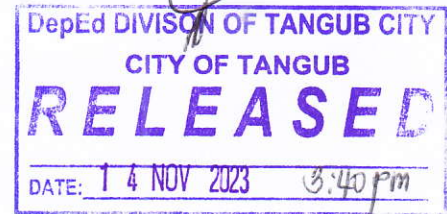

**CONDUCT OF LEARNING ACTION CELL (LAC) SESSION  
ON CODE OF ETHICS FOR PROFESSIONAL TEACHERS**

1. The Department of Education (DepEd) has implemented the Learning Action Cell (LAC) as a K to 12 Basic Education Program School-Based Continuing Professional Development Strategy for the Improvement of Teaching and Learning, as outlined in DepEd Order No. 35, s. 2016. This policy aims to support the continuous professional development of teachers and enhance their potential for success in their profession.
2. The Office of the Schools Division Superintendent (OSDS) emphasizes the importance of upholding the Code of Ethics for Professional Teachers in promoting excellence and integrity in the teaching profession. Thus, Learning Action Cell (LAC) session per school is scheduled to deepen our understanding of the Code of Ethics and its application in our daily teaching practices.
3. The purpose of this LAC session shall: enhance awareness and comprehension of the Code of Ethics for Professional Teachers; provide a platform for collaborative discussion on real-life scenarios related to the Code of Ethics; and, foster a culture of professionalism and ethical behavior among teaching personnel.
4. Conduct of this LAC Session shall be subject to the 'no-disruption policy' stipulated in DepEd Order No. 9, s. 2005, "Instituting Measures for Increase Engaged Time-on-Task and Ensuring Compliance Therewith", thus the suggested schedule will be on November 17, 2023 and (or) November 24, 2023 at 3:00pm to 4:30pm.
