Bids received in excess of the ABC shall be automatically rejected at bid opening.

 6. The Department of Education – Division of Tangub City will hold a Pre-Bid Conference on November 30, 2023, 9:00 AM at Division Office Conference Hall which shall be open to prospective bidders.
 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before 1:29 P.M. on December 12, 2023. Late bids shall not be accepted.
 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
 9. Bid opening shall be on December 12, 2023, 1:30 P.M. at the given address below. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
