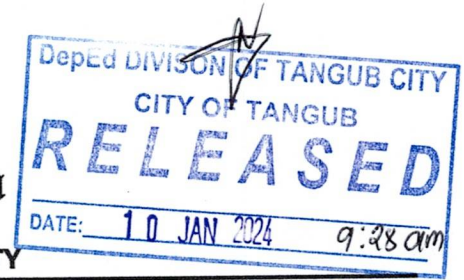

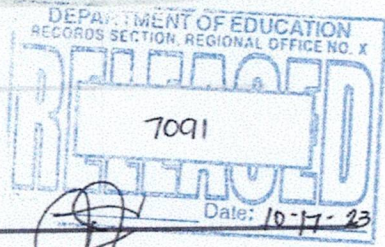
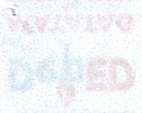

1. Following Section 42-44, Article IV of Republic Act 9165 otherwise known as the "Comprehensive Dangerous Act of 2002 and DepEd Order No.12, series of 2009 "Strengthening the National Drug Education Program (NDEP) in School, the Education Support Services Division (ESSD) of Regional Office X will advocate the **Involvement of School Division Offices, District Offices and School Officials to City/Municipal/Barangay Anti-Drug Abuse Council (CADAC/MADAC/BADAC).**

2. This aims to
- a. strengthen the implementation of the National Drug Education Program (NDEP);
 - b. motivate program implementers to manifest enthusiasm, leadership, and deeper commitments to the implementations of the program;
 - c. Intensify school-local government unit (LGU) collaboration in maintaining an entirely drug-free environment in the school, home, and community; and
 - d. improve the sustainability of drug prevention advocacy.

3. Based on DepEd Order No. 30, s. of 2018 "Preventive Drug Education Program Policy for Curriculum and Instruction," the duties and responsibilities of the School Head are to *coordinate with the appropriate offices and other agencies or instrumentalities for appropriate assistance and intervention, as may be required in the performance of his/her function* and the Department of Interior and Local Government (DILG) and Dangerous Drugs Board (DDB) Joint Memorandum Circular No. 2018-01, stated in the organizations and functions as follows:
