PARTICIPATION TO THE CITY FIESTA ACTIVITIES

To: Assistant Schools Division Superintendent
 Chief Education Supervisors (CID & SGOD)

 All Others Concerned

1. Pursuant to the Republic Act (RA) 9155 known as the Governance of Basic Education Act of 2001, the Department of Education (DepEd) strengthens its partnership to school stakeholders. Further, this policy aims to recognize and reinforce the role of school stakeholders alongside with the Local Government Units (LGUs), as partners in providing learners accessible and quality education, upholding children's rights, and promoting respect and well-being in the learning environment to ensure effective education service delivery.

2. Hence, this Office through the School Governance and Operations Division (SGOD) announces its participation to the City Fiesta Activities provided that all affected teachers and learners will strictly adopt the Blended Learning Delivery Modality (**BLDM**) to ensure the continuity of learning without compromising the quality of education. Thus, schools must communicate and orient the parents with regards to this modality for commitment and support for learning (*DO 10, s. 2024, rationale 24*). Additionally, schools must secure parental consents from parents/guardians to indicate that they are allowing their children to participate the off-campus activities (*DO 66, s. 2017*).

3. To conform with the provision of DO No. 9, s. 2005 (Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith), teachers of the participants are required to provide home learning tasks that are suited to the specific learning needs of the learners and must ensure access to print/non-print Self-Learning Modules (SLMs) and home learning plan to guide learners in accomplishing the assigned tasks.

4. School Heads of the affected schools must submit the **BLDM** Plan to the Office of the Schools Division Superintendent through the Office of the Curriculum and Implementation Division (**CID**) on or before August 27, 2024.

5. Per DO 66, s. 2017 otherwise known as **Implementing Guidelines on the Conduct of Off-Campus Activities**; attached are the Forms 1, 2, & 5 to be accomplished by the participating schools on or before August 27, 2024.




