As provided in the Republic Act (RA) 10533, titled an Act Enhancing the Philippine Basic Education System by strengthening its curriculum and increasing number of years for Basic Education, appropriating funds therefore and for other purposes, and DepEd Order No. 021, s 2019, titled Policy Guidelines in the K to 12 Basic Education Program, consistent with the DepEd goal of producing functionally literate and holistically developed Filipinos, thus, **Sports, Festival of Talents, and Schools Press Conference** are aligned with the essential learning competencies and standards of the K to 12 curriculum. Hence, this Office announces the simultaneous conduct of the three (3) events on the schedules stipulated below.

3. Event organizers must ensure that **Parental Consents** of participants are secured prior to the conduct of the activities.
4. School Heads and teachers who are involved in the activities are advised to implement the Alternative Delivery Modality (ADM) to ensure the continuity of learning.
5. Expenses incurred in the conduct of the three (3) events within the schools and districts shall be charged against school's local funds while expenses of the events in the Division level may be charged to Special Education Fund (SEF), and local funds subject to the usual accounting and auditing rules and regulations.
6. School Heads and PSDICs are directed to submit **Activity Matrix** of the three (3) events for approval from the office of the Schools Division Superintendent (SDS) and submit copy of the approved **Sports Activity Matrix** to the office of the School Governance and Operations Division (SGOD) and the **Festival of Talents and Schools Press Conference Activity Matrix** to the office of the Curriculum Implementation Division (CID) for monitoring and provision of technical assistance.
7. Detailed Activity Matrix in each event will be issued in a separate Memorandum.
8. Immediate dissemination of this Memorandum is highly desired.
