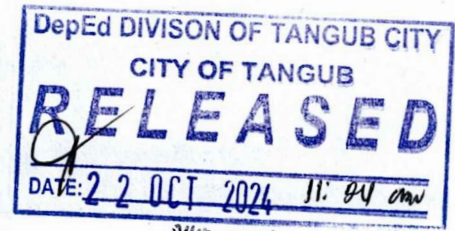

5. All concerned process owners shall present their corresponding QMS Processes and other documents during the activity.


