### MODULAR DISTANCE LEARNING (MDL) FOR 2025 NMRAA QUALIFIERS

1. In adherence to **DM 390, s. 2023** titled Maximizing Instructional Time and Utilizing Self Learning Modules (SLMs) for Alternative Delivery Modes (ADMs), this Office allows its implementation for the learner athletes and teacher coaches who qualified for the Northern Mindanao Regional Athletic Association (NMRAA) Meet on March, 2025. Henceforth, classes of the *learner athletes* and *teacher coaches* in every **Tuesday**, **Wednesday**, and **Thursday** may be supplemented with SLMs for them to have time to practice its specific event and to ensure that no competency is compromised, learning delivery is instituted and mastery of learning is achieved (#5, DM 390, s. 2023).


