

## CITY RESOLUTION NO. 2024-10-605

A RESOLUTION AFFIRMING, CONFIRMING AND CONCURRING EXECUTIVE ORDER NO.146, SERIES OF 2024, ENTITLED "AN ORDER DIRECTING PUBLIC PRE-SCHOOL TO GRADE 7 TO COMPLY WITH THE SCHOOL-BASED IMMUNIZATION PROGRAM IN THE CITY OF TANGUB"

WHEREAS, Executive Order No. 146, Series of 2024, as cited above, has been duly received for consideration;

WHEREAS, the School-Based Immunization (SBI) is a program of the Department of Health (DOH), in coordination with the Department of Education (DepEd), that aims to provide protection against vaccine-preventable diseases (VPDs) such as measles, rubella, tetanus, diphtheria and human papillomavirus (HPV);

WHEREAS, SBI is a vital component in the implementation of Universal Health Care (UHC) since this program ensures equitable access to vaccines, protecting school-aged children from vaccine-preventable diseases and aims to engage healthcare providers, educators, and local

government units to guarantee smooth and efficient vaccine administration and ensure strong coordination across sectors to expand access to health services, especially in rural areas;

WHEREAS, the Local Government Code of 1991 (RA No. 7160) accords every local government unit power and authority to promote the general welfare within its territorial jurisdiction, including the promotion of health and safety of its constituents;

WHEREAS, low immunization coverage in the city will translate to rendering children susceptible to vaccine-preventable diseases and thereby threatens the country to outbreaks/epidemics despite of the national purchases of a free, potent and high-quality vaccines for all infants, children and mothers;

WHEREAS, immunization coverage based on health centers report of Field Health Service information System of Fully Immunized Children (FIC) from 66% in 2022 to 79% in 2023, far from the 95% target set by the Department of Health;

WHEREAS, there is a need for all public schools in the City of Tangub to participate in the nationwide School-Based Immunization Campaign to achieve the highest immunization coverage;

WHEREAS, achieving 95% fully immunized school children will require unified commitments of the national government, local government unit, school heads, health workers, communities, parents and all sectors of the society;

**NOW, THEREFORE,** upon motion of Honorable Rose N. Buenafe and severally seconded by the present members of the Sanggunian, it was;

RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Tangub City, to affirm, confirm and concur Executive Order No. 146, Series of 2024, entitled "An Order directing Public Pre-school to Grade 7 to comply with the School-Based Immunization Program in the City of Tangub";

**RESOLVED FURTHER**, that copies of this Resolution be furnished to all concerned offices for their information, guidance and appropriate action.
