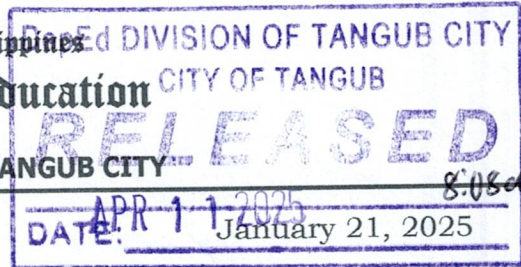

1. In compliance with the MATATAG Agenda of taking good care of learners by promoting learner well-being, inclusive education and positive learning environment and pursuant to DepEd Order No. 47, s. 2014 titled Constitution and By-Laws of the Supreme Pupil Government and Supreme Student Government in Elementary and Secondary Schools, this Office through the School Governance and Operations Division – Youth Formation Section will conduct a Division Basic Leadership Training Cum Election of Division Federation of Supreme Elementary Learner Government (DFSELG) and Division Federation of Supreme Secondary Learner Government (DFSSLG) Officers for School Year 2025-2026 on March 14, 2025 at the Division Office Conference Hall.
2. This activity aims:
 - a) To capacitate learner leaders on their constitution and by-laws;
 - b) To equip learner leaders with the skills to support their peers in making informed decisions and in accessing necessary programs and services; and
 - c) To elect DFSELG and DFSSLG Officers for School Year 2025-2026.
3. Participants are newly elected Supreme Elementary Learner Government (SELG) Presidents, newly elected Supreme Secondary Learner Government (SSLG) Presidents and their Teacher-Adviser/Chaperone. Participants from Integrated Schools shall send one (1) Teacher-Adviser/Chaperone for both SELG and SSLG Presidents of their school.
