- Anchored on DepEd Order No. 24, s. 2020 otherwise known as National Adoption and Implementation of the Philippine Professional Standards for School Heads (PPSSH) with domains of Leading Strategically, Managing School Operations and Resources, Focusing on Teaching and Learning, Developing Self and Others and Building Connections, the said activity is aimed to:
 - Present the accomplishments, performance indicators, and current status of school programs and services;
 - · Highlight challenges, issues, and areas for improvement based on data;
 - Lay down strategic directions, innovations, and initiatives for the next school year;
 - Promote accountability and stakeholder participation in school governance.

 - 3.1. All school heads are required to prepare a digital 10-minute presentation aligned with the theme: 'The Present Condition and Future Direction of the School (Kahimtang ug Padulngan sa Eskwelahan) for submission to OSDS on or before June 6, 2025 through google link https://tinyurl.com/tekedrff 3.2. The presentation shall cover the following: a) School Profile; b)

 - 3.3. The presentation must be supported by data, reports, and visuals (charts, photos, infographics, etc.);


