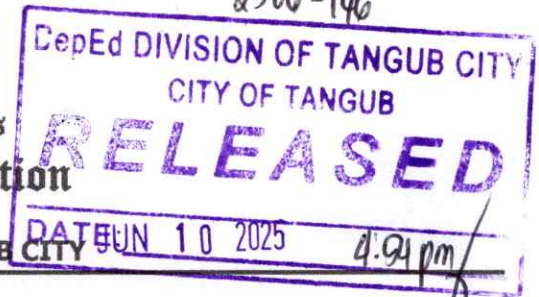

**UPDATED DIVISION MEMORANDUM (DM) 246, S. 2024
ON READINESS TO CLASSROOM-BASED AND OTHER ASSESSMENTS**

1. With reference to DepEd Order No. 012, s. 2025 titled Multi-Year Implementing Guidelines on the School Calendar and Activities, all forms of assessment as indicated in DM 246, s. 2024 are hereby updated to provide guidance to all schools and other concerned individuals in planning appropriate interventions and in preparing all learners for the assessment, in adherence to assessment policies and guidelines.

2. The table below is the indicative schedule in the administration of the different assessments per DO 012, s. 2025.

System/Classroom Assessment	Date
Pretest (CRLA, RMA, Phil IRI, Phil ECD, MFAT, etc.)	June 16 to July 16, 2025
ELLN Testing Window	July 28 to August 1, 2025
First Quarter Examination	August 20-22, 2025
NAT 10 Testing Window	August 26 to September 1, 2025
NCAE Testing Window	September 8 to 26, 2025
PEPT	October 19, 2025
Second Quarter Examination	October 23-24, 2025
NAT Grade 12 Testing Window	January 19 to February 6, 2026
Third Quarter Examination	January 22-23, 2026
Testing Window of CRLA, RMA, Phil IRI, Phil ECD, MFAT, etc.	February 18-March 18, 2026
A & E Test	February 22, 2026
EOSY CRLA, RMA and Phil IRI	March 9-20, 2026
Fourth Quarter Examination	March 19-20, 2026

3. All schools shall continue to implement the policy on Monday as Formative Assessment Day per Division Memo No. 04, s. 2024. The sample assessment tool shall be attached to the Lesson Exemplar or Daily Lesson Log (DLL), to be checked by the school head.

4. On the Readiness of Schools in the regional and national assessments, all schools are advised to continue implementing the Division Memorandum No. 05, s.




