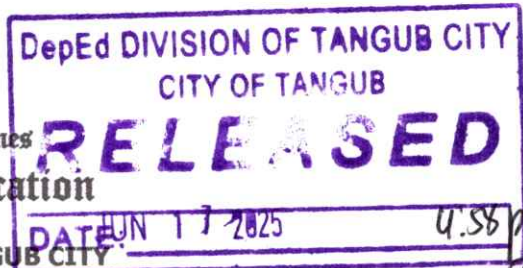

1. Regarding the implementing guidelines and the schedule of the 2025 Palarong Pambansa, this Office will hold a school-based training program and/ or enhancement to all the participating NMRAA athletes for all team and individual sports (including demo sports) at their respective schools from April 21 to May 9 and pre-departure encampment on May 14-19.
2. The 2025 Palarong Pambansa will be held in Ilocos Norte, from May 24 to June 1. As part of the preparatory activities, the training for all participating athletes shall be held in their respective schools.
3. Athletes, coaches, and other authorized participating DepEd and non-DepEd personnel are all expected to arrive at the billeting quarter (Laguindingan National High School) in Misamis Oriental, on May 14.
4. Moreover, the NMRAA delegation is then expected to travel to Ilocos Norte, on May 19.
5. The transportation of athletes, coaches, and officials from the stations to the training/billeting quarters shall be charged against local funds while the meals for the training shall be charged to the Regional Office (RO) funds, subject to the usual accounting and auditing rules and regulations.
6. Invited tournament directors (TDs) and assistant tournament directors (ATDs) of the 2025 Palarong Pampook (NMRAA) (as indicated in the attached list of training officials) are instructed to visit the athletes during the school-based training and implement three-day sports clinics for both athletes and coaches in their sporting events during the training period. The sports clinics shall cover the technicalities, including guidance for the coaches on the most common errors made by the athletes. For this purpose, the transportation and other incidental expenses of the invited TDs and ATDs for the entire three-day sports clinics shall be charged against local funds, subject to the usual accounting and auditing rules and regulations.
