1. As provided in the Republic Act **(RA) 10533**, titled an Act Enhancing the Philippine Basic Education System by strengthening its curriculum and increasing number of years for Basic Education, appropriating funds therefore and for other purposes, and **DepEd Order No. 021, s. 2019**, titled Policy Guidelines in the K to 12 Basic Education Program, consistent with the DepEd goal of producing functionally literate and holistically developed Filipinos, thus, **Sports, Festival of Talents, and Schools Press Conference** are aligned with the essential learning competencies and standards of the K to 12 curriculum. In coherence, this Office announces the simultaneous conduct of the three (3) events on the schedules stipulated below.

2. To conform with the provision of DO No. 9, s. 2005 (Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith), all public schools and districts in this Division are enjoined to conduct simultaneously the three (3) events on the following dates:

4. School Heads, teachers and learners involved in the activities are directed to use the Alternative Delivery Modality (**ADM**) to ensure the continuity of learning.
5. Expenses incurred in the conduct of the three (3) events within the schools and districts shall be charged against school's local funds while expenses of the events in the Division level may be charged to Special Education Fund (SEF), and local funds subject to the usual accounting and auditing rules and regulations.
6. School Heads and PSDICs are directed to submit **Activity Matrix** of the three (3) events for approval from the office of the Schools Division Superintendent (SDS) and submit copy of the approved **Sports Activity Matrix** to the office of the School Governance and Operations Division (SGOD) and the **Festival of Talents and Schools Press Conference Activity Matrix** to the office of the Curriculum Implementation Division (CID) for monitoring and provision of technical assistance.
7. The unified opening program for the three events will be on July 21, 2025 at People's Gym, 8:00AM.
8. Program holders of the three events are directed to convene and perform the **PRE-WORK** on the details of the unified opening program on **June 23, 2025** at **Division Conference Hall, 3:00PM**.
9. Detailed **Activity Matrix** in each event and the **Program** for the unified opening will be issued in a separate Memorandum c/o program holder.
10. Immediate dissemination of this Memorandum is highly desired.
